**Europe's leading and fastest-growing congress and trade fair for law and compliance, LEGAL REVOLUTION, will be held in Nuremberg for the first time on 3 and 4 May 2023. In future, the event will be jointly organised annually by NürnbergMesse and EDRA Media GmbH. Due to the Corona pandemic, LEGAL REVOLUTION had to be postponed last year.
